

**Cohasset Select Board
Public Hearing Notice**

The Cohasset Select Board, acting as Local License Authority, will hold a remote public hearing on Tuesday, January 18, 2022 at 7:05 PM **virtually via a Zoom webinar**, to consider the application of Split Rock Social, Inc d/b/a Split Rock Social, 12 Parkingway, Cohasset, MA for a new §12 on premises, Wine and Malt Beverages License. The licensed premises will be a seasonal (April through October) Oyster Bar and Beer Garden that will be an entirely outside concept, located in the rear parking lot of 12 Parkingway in Cohasset. All food, beer and wine service will take place in a 3,500 square foot outdoor patio that will be almost entirely enclosed aside from one main entrance and three emergency exits. All beer and wine will be poured from an enclosed shipping container bar which also includes 3 restrooms, one of which is ADA compliant. During non-business hours, the container bar, along with all on-site beer and wine, will have the ability to be locked up for storage and safety.

The public is invited to offer public input and ask questions regarding this application in writing by emailing joram@cohassetma.org in advance of the public hearing, and can also attend via the Zoom Platform; details for access to the Zoom platform are below and will also be on the Select Board's agenda posted on the Town's website at www.cohassetma.org. on the calendar section of the website, located on the lower part of the front page of the website.
