The Town was not accepted into the program, so they are reapplying. **Motion by Select Member Dippold-Having convened in an open meeting on April 11, 2023, prior to the SOI submission closing date, the Select Board of the Town of Cohasset, in accordance with its charter, by-laws, and ordinances, has voted to authorize the Superintendent to submit to the Massachusetts School Building Authority the Statement of Interest Form dated March or April 2023, for the Cohasset Middle School located at 143 Pond Street, Cohasset, MA which describes and explains the following deficiencies and the priority category(s) for which an application may be submitted to the Massachusetts School Building Authority in the future, including: elimination of existing severe overcrowding; replacement, renovation, or modernization of school facility systems, such as roofs, windows, boilers, heating and ventilation systems, to increase energy conservation and decrease energy related costs in a school facility; replacement of or addition to obsolete buildings in order to provide for a full range of programs consistent with state and approved local requirements; including deficiencies presented to this Board by the School Facilities Committee Assessment Report and hereby further specifically acknowledges that by submitting this Statement of Interest Form, the Massachusetts School Building Authority in no way guarantees the acceptance or the approval of an application, the awarding of a grant or any other funding commitment from the Massachusetts School Building Authority, or commits the Town of Cohasset to filing an application for funding with the Massachusetts School Building Authority, seconded by Select Member Grady.
